IMPORTANT: PLEASE READ THE <u>ENTIRE</u> INSTRUCTION MANUAL BEFORE STARTING THIS INSTALLATION.

Note: The Hotchkis Lower Control Arm design is based on the <u>68-73</u> mounting style strut rod. If you have a 67 Mustang or have 67 style strut rods, then you will need to upgrade to the 68-73 style strut rods to run these arms.

Lower Control Arm Installation

1 Raise the Vehicle

Raise the front end of the vehicle with a lift or support with jack stands. Front wheels should be off the ground.

- 2 *Remove the Front Wheels* Remove the front wheels and set aside
- 3 *Remove the Sway Bar Link* Unbolt the sway bar end link from the lower control arm. Retain this hardware for reinstallation.

4 Unbolt the Ball Joint

Remove the cotter pin from the lower ball joint.

Loosen but do not remove the castle nut that holds the ball joint stud in the spindle. Leave about a 1/8" of gap between the nut and the spindle mating surface.




The ball joint stud is taper pressed in the spindle mount. To remove the stud from the spindle force and/or impact is required to break the press fit. There are a number of ways to do this, but the best method is to make an inexpensive tool with




off the shelf components. Go to the hardware store and pick up and a specific and position it between the upper and lower ball joint studs. Unscrew the bolts until you have a moderate amount of tension. Grab a hammer and tap on the side of the spindle mount. The taper fit should pop loose rather easily. Support the lower control arm and spin the Lower ball joint castle nut right off.

Tool Components:

- (x1) Coupling Nut 3/4"-10 x 2.25" long (Mcmaster Carr 90977a215)
- (x2) Hex Bolt 3/4"-10 x 1.75" long (Mcmaster Carr 92865a841)







5 *Disconnect the Lower Control Arm from the Car* Unbolt the inner bushing bolt. Retain this hardware for reinstallation. The arm should be free from the vehicle.





Install Hotchkis Arm Inner Mounting Point Grab your Hotchkis lower control arm and reinstall in the same manner as removal.

Adjust the Hotchkis arm to an initial length of 15.75"



Start with the inner mounting point. You will need to insert the provided stainless steel spacer between the clevis mount and the Hotchkis swivel joint. Tighten this bolt down.




7 Attach the Hotchkis Ball Joint to Spindle

Insert the Hotchkis ball joint stud into the spindle mounting hole. Make sure the tapered surface on the spindle is clean and free of debris. Once seated, install the spacer on the stud and follow with the castle nut. Tighten the nut and make sure the slot lines up with the hole in the stud. Insert the cotter pin and bend the ends to lock in place.



8 Reinstall the Strut Rod to the Lower Control Arm

The Hotchkis kit comes with new hardware to fasten the strut rod to the arm. Insert the bolt plate from the bottom of the LCA and have it pass thru the arm and strut rod. Place the washers and nylock nut on top and fully tighten.



9 Alignment Tips

Once the installation of the lower control arms is complete, please perform a front wheel alignment. We highly recommend using our Hotchkis Upper Control arms (1118U) and Adjustable Strut Rods (14416) in conjunction with the lower control arm kit to take full advantage of this system.

One of the benefits of the Hotchkis Lower Control Arm is the swivel bushing we provide with this kit. The swivel bushing does not deflect like the old OE rubber

bushings do. This keeps the alignment consistent and dramatically results in guicker SPORT SUSPENSIONE swive allows the customer to gain more positive 8633 SOHENSEN AVE. SANTA HUSPHINGS swive allows the customer to gain more positive caster (with adj. strut rods) without unwanted bind that rubber bushings can exhibit.

The 1117L-ADJ kit adds the advantage of camber adjustment via the lower arm for an additional range of $+3^{\circ}$ to -3° .

Mostly Street/Occasional Autocross Alignment Camber: -1.5° Caster: +6° Toe: 1/16" toe In

Autocross/Track/Race Alignment Camber: -2° to -2.5° Caster: +6° or more with adjustable strut rods Toe: Zero toe to 1/16" toe out

(Note: Alignment specs based on vehicles equipped with Hotchkis upper & lower control arms and adjustable strut rods.)

Procedure for adjusting Hotchkis lower control arm:

- Measure camber at ride height.
- Raise the front of the vehicle until the front wheels are off the ground.
- Undo the inner mount for the lower control arm
- Loosen the LCA jam nut, adjust the inner joint to make the arm longer or shorter depending on what camber you need.
- Reattach lower control arm and drop the vehicle back to ride height.
- Re-measure the camber. Repeat the process until desired camber is acheived.
